INSTRUCTION (please read carefully)

La Macina di San Cresci provides an opportunity for artists to work in the studio-based at its Artist-in-Residency program. The centre is a meeting place and residency for artists from around the world.

Eligibility :

Open to visual artists from any country working in any media

Recipients must be at least 18 years of age at the time of their residency.

1. **APPLICATION MATERIALS** (All of the following materials must be included with the application in order for it to be processed).
 - A. Application form filled
 - B. One-page, Project description, explaining what the artist wants to realize during the residence.
 - C. One page, Bio/Resume/Professional Summary, this should include educational background, teaching, publications, exhibitions, awards, honors and other pertinent experience.
 - D. Artist Statement (maximum 2000 characters- app. 400 words)
 - E. Work samples as specified below

2. **WORK EXAMPLES** should be recent and representative of the work according to the applicant's medium and discipline .
You may send up to 20 representative photos in paper format or a CD with digital images of your work. Please include a list that corresponds to your images ; DVD or music CD with 10 minutes maximum duration; or written documents up to 10 pages in length.
Digital images must be submitted as JPEG, if sent by email, max 4MB total.

3. **RETURN OF MATERIAL:** We no longer return material. Please make sure to send us only copies, not original works.

4. **VISA** :If the artist comes from non-European country, he/she will have to go through the process of obtaining a Visa valid throughout the time of residence. We offer our collaboration by writing a letter of admission.

5. **RESIDENCY:** The artist must take responsibility to pay individually for the residency fee and insurance, transport ,travel expenses, meals and personal costs. Normally the artist will look for a grant in his/her country to finance all the costs, although La Macina di San Cresci will do everything possible to facilitate the search for financial Aid, i.e. sending a letter of invitation that endorses the decision of the artist.

6. RESIDENCY FEE: 1 week € 400, each next week € 300.

Is included :

- Housing in the historical complex of Pieve di San Cresci for the duration of the program including studio space, single room.
- Support staff for orientation and general assistance.
- Attendance to the workshop in several disciplines (when scheduled).
- Use of the facilities available at La Macina.
- Inclusion in the Yearbook and website.
- Electricity, water, Internet access.
- Linen and towels are provided. Washing machine available.
- Final housecleaning service.
- Two mountainbikes are available for free.
- An automatic car is available for a small fee.

Is NOT included :

- Heating and gas. The costs are paid cash in according to the use, the day before your departure.
- The residents are expected to pay their own travel arrangements to and from the retreat and Visa (if necessary) , including a medical assistance. We strongly recommend that you take steps to adequately cover yourself against illness, accident, etc before leaving your home town. La Macina di San Cresci will not responsible, at any time or under any circumstances, for medical fees in case of illness, accident, etc.
- The residents are also responsible for all working materials, personal needs , meals and living costs.

7. Payment Policy

Is requested a deposit of € 200 when the applicant receives acceptance of candidature. Balance is due 30 days before the sojourning beginning through Bank transfer.

8. Refund Policy

Deposit is non-refundable. Any cancellation must be made in writing by regular mail or email .No reimbursement if you cancel your residency 3 weeks or less before the sojourning beginning .

9. Accommodation

The house is located in a very silent and peaceful area.

Apartment "Artist's house", is situated on the first floor.

Each resident will have a private room. Residents may share kitchens and bathrooms. Even though residents have private rooms , this is still a group living situation. If that is difficult for you, don't apply. No really, it's important that the residents be flexible and open to others needs.

Some rules and regulations must be observed in order to ensure a pleasant and efficient working atmosphere. So, we request residents to maintain both the studios and the accommodation area clean and tidy as well as to respect all equipment in the Centre.

The renter takes care of cleanliness of the dwelling and working rooms used.

10. Agreement

The artist, by signing the application form authorizes the use of images / videos of works and any other material submitted with the application.

By signing the application form, you are agreeing to accept all the above conditions.
